#### **Brief about Event**

D. K. V. Arts & Science College, Jamnagar, in collaboration with SUSEC, IIC, and SPRIHA Saurashtra University, organized a seminar on the occasion of World Entrepreneurs Day on 21st August 2025. The event aimed to inspire students towards entrepreneurship and innovation while highlighting the crucial role of intellectual property rights in protecting innovative ideas.

The program commenced with an introduction to the significance of World Entrepreneurs Day, a day dedicated to encouraging entrepreneurial spirit, recognizing innovators, and fostering startup culture in academic institutions.

The first session was conducted by Ms. Anjali Rathod, Research Assistant, SPRIHA, Saurashtra University, on the theme "IPR for Startups." She highlighted how intellectual property rights (IPRs) serve as the foundation for protecting innovative ideas and technologies developed by startups. Ms. Rathod explained the different types of IPR-patents, trademarks, copyrights, and designs-and their significance in a competitive business environment. She emphasized that patents protect inventions, trademarks build brand identity, and copyrights safeguard creative works. She further elaborated on how a well-managed IPR portfolio can enhance a startup's credibility. attract investors, and create opportunities for licensing and commercialization, Real-world examples were shared to help students understand how startups leverage IPRs for growth and protection against infringement.

The second session was led by Ms. Urvi Kanabar, Operation Assistant, SUSEC, Saurashtra University, the topic "How to Become Entrepreneur." on an Her session focused on guiding students through the entrepreneurial journey, starting from idea generation to establishing a business. She explained how students can identify problems, validate solutions, and transform innovative ideas into marketable products or services. Ms. Kanabar introduced the role of incubation centers, mentorship programs, and funding schemes in supporting early-stage entrepreneurs. She also highlighted government initiatives, startup policies, and university-led programs that offer vital resources to budding entrepreneurs. Through interactive discussion, she encouraged participants to develop a growth mindset, embrace risks, and take the first step toward entrepreneurship.

Both sessions provided participants with practical knowledge as well as inspiration to pursue their entrepreneurial aspirations. The event also showcased how educational institutions and innovation councils are actively contributing to shaping young entrepreneurs.

The program concluded with an interactive Q&A session, where students shared their queries on startup challenges, IPR procedures, and opportunities available through incubation and mentorship support.
